PUBLIC FOOTPATHS NO. 124 AND 125 SOUTH STREET, SEBASTOPOL

TEMPORARY PROHIBITION OF PEDESTRIANS ORDER 2025

NOTICE is hereby given that the County Borough Council of Torfaen in exercise of their powers under the Road Traffic Regulation Act 1984 (as Amended) intend not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians and cyclists from proceeding along Public Footpaths No. 124 and 125. These adjoining Footpaths run along the canal towpath at South Street, Sebastopol in a north-easterly south-westerly direction for approximately 310m and 212m. The Footpaths are shown by two bold black lines from A-B and C-D on the Order Map.

Alternative routes are available via Wern Road and Alma Place/Richmond Road and are shown on the Order Plan by dashed black lines marked E-F and G-H.

The prohibition is necessary because works are being or proposed to be executed on or near the footpath.

The proposed Order will come into operation on 12 February 2025 and will continue in force for a period of 6 months or until the works have been completed, whichever is the sooner.
