TEMPORARY PROHIBITION OF PEDESTRIANS ORDER 2025

NOTICE is hereby given that the County Borough Council of Torfaen in exercise of their powers under the Road Traffic Regulation Act 1984 (as Amended) intend not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians and cyclists from proceeding along Public Footpath No. 19, running west of Bevans Lane, Pontrhydron for approximately 420 metres. The Footpath is shown by a bold black line from A-B on the Order Map.

An alternative route is available and is shown on the Order Plan by a dashed black line marked C-D.

The prohibition is necessary because works are being or proposed to be executed on or near the footpath.

The proposed Order will come into operation on 3 January 2025 and will continue in force for a period of 6 months or until the works have been completed, whichever is the sooner.


